



# Handbook Builder: Policy Updates

***For those clients that have their employee handbook(s) in the ADP® Handbook Builder and need to get a policy(ies) updated, please follow these steps:***

# 1

In the **Notifications** section of the Dashboard, on the right-hand side of the screen, you will see a list of **Policy Updates** that may be applicable to your company.

# 2

Click on **Complete Handbook** in the Dashboard if your handbook is still in progress. If your handbook has already been published, click on **Manage Handbook** in the Dashboard.

# 3

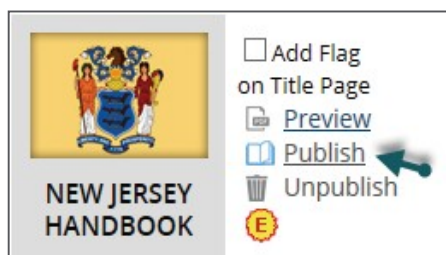
In the **Search Policy** section, enter the name of the policy title that has an update and you will be taken to that particular policy. You will note that the policy has a flashing “P” that symbolizes that the policy is updated.

# 4

Once you are in the applicable policy, you can click on **Policy Update** in order to compare and apply the policy updates. Once you are finished with the compare, you click on **Edit Changes**, then click on **Copy & Save All Changes to my Current Version**, and lastly click on **Save Changes**. You follow this step for each applicable policy that needs to be updated.

# 5

Once the applicable policies have been updated, go back to the **Dashboard** and click on **Publish Handbook**. Once you are directed to your employee handbook, click on **Publish**, as shown below, so that the handbook gets re-published within the handbook builder.



We recommend that clients distribute the updated handbook and/or updated policies, and that employees acknowledge receipt of the updated handbook in writing. The acknowledgement should be maintained in the employee’s personnel file. The handbook can be printed via the handbook builder by accessing the Dashboard and clicking on **Print Handbook**. Please feel free to use the Acknowledgment form that is at the end of this instructional guide to give to your employees, along with the updated policy(ies).
